The program committee will issue a decision on acceptance lecture or poster to **25 May**. The decision will be sent only by e-mail! The scientific program will include submissions, key lectures of invited guests, organized discussions and poster session.

INSTRUCTIONS FOR PRESENTERS

The official conference language is Slovak / Czech / English.

ABSTRACT SELECTION CRITERIA

The program committee will review all abstracts registered for the conference and make a selection based on the content, purpose, relevance to the focus of the conference etc. The deadline for abstracts registration is 18 May 2012. All persons who register their abstracts, will receive a decision of the Committee on acceptance/rejection of contributions by 31 May 2012. Send your abstracts as soon as possible to avoid complications in the admission process. If sending abstract, please indicate whether it intended to lecture or poster presentation.

FEES

Presenters conference participants, in addition to key invited speakers, have to pay their own travel and other expenses and are required to pay the corresponding filing fee, which is reduced to the speakers. The deadline for payment of registration fee for presenters is 31 May 2012. In case the registration fee is not payd in full before the aforementioned date, the abstract will not be included in the final Conference Programme & Book of Abstracts..

ABSTRACT FORMAT

The purpose of the abstract is to define the precise subject of the presentation to an audience. Font must be Times New Roman, size 11 point. All typing should be single-spaced. Title, Author's name(s), Affiliation (institution, city, and country) and presenter's e-mail address should all be centered, and the body of the abstract should be full justified. The Title must be in bold text. Please underline the name of the presenting author. Leave one blank line between the presenting author's e-mail address and the beginning of the body of abstract. A new line may be used for each paragraph in the body of the abstract. All margins (top, bottom, left and right) must be set to 2.5 cm.

PRESENTATIONS

The Conference Programme Committee invites those who wish to contribute to the conference to submit an abstract. **Duration of oral presentations should be 15 minutes + 5 minutes for discussion.**

All oral presentations are to use MS Power Point presentation format (.ppt). Laptop computers and projectors along with screens will be available in the conference room. Please bring your presentation to the Conference either on a CD/DVD or USB stick drive (no exceptions). Presentations should be loaded onto the DEDICATED PC at least one hour before the start of the Conference. Due to time constraints, no presenter will be allowed to connect his/her laptop to the session projector.

POSTER PRESENTATIONS

The Conference Programme Committee will be selecting poster presentation abstracts for the Conference Poster Session. Presenters are kindly asked to bring (or send in advance) posters, if possible. Posters will be on display during the days of conference on poster boards. Each poster should be 90 cm width x 120 cm height or smaller. Tacks will be available. You are responsible for any other special poster mounting needs that you may require. Posters must be set up an hour before start of the Conference . Organizers will communicate the poster place and numbers to presenters via e-mail.


PROCEEDINGS
